1. Quality Precast Company and/or Quality Block & Supply, Inc., hereafter referred to as the Seller agrees to sell to Individual/Business ENTITY applying for credit hereafter referenced as the Buyer, goods described on face of invoice at the price quoted by its agent or in writing.
2. Buyer agrees to pay for goods at Seller's offices in accordance with Seller's terms, which are: NET DUE 10<sup>th</sup> of month following date of invoice
3. Invoices are considered PAST DUE on the 20<sup>th</sup> day following date of invoice.
4. Finance charges shall incur on past due invoices at the highest rate allowed by Florida law, and specifically including post judgment finance charges.
5. VENUE: Any Action brought to enforce rights under this agreement will be controlled by laws of Florida, and the parties agree that venue of any action will be in Hillsborough County, Florida.
6. Buyer agrees to reimburse Quality Precast Company and/or Quality Block & Supply, Inc. for all costs that are incurred in the recordation of construction liens and the recordation of satisfactions of the construction liens recorded as a result of Buyer failing to make payment for materials purchased from Quality Precast Company and/or Quality Block & Supply, Inc. in accordance with the terms herein.
7. Any deviation of billing terms must be made and agreed to by the seller prior to the account being approved.
8. All claims for shortages or damages must be made within 48 hours of delivery.
9. Seller must agree in advance before the buyer returns any and/or all goods purchased by buyer. Returned items must be in saleable condition. Seller has the right to charge buyer up to a 30% service charge for any returns accepted by seller.
10. Buyer must be in receipt of a Credit Memo issued by seller before any deductions are made from payments made to seller.
11. Buyer agrees to accept Florida Statutory Lien Release Forms, after payment has been made.
12. Buyer agrees to not withhold/retain any funds from payments due seller as a result of contractual obligations the buyer may have with other parties, including pay when paid clauses.
13. Seller reserve the right to increase or decrease credit limits at any time it chooses.
14. Seller reserves the right to refuse or revoke credit at any time and for any reasons.
15. Buyer agrees that in exchange for Seller granting Buyer credit privileges, the buyer acknowledges this to be a binding agreement that supersedes any and all other written agreements between seller and buyer.
16. Buyer agrees to notify the seller in writing within 5 business days of any change in ownership, business address and/or e mail addresses, and/or phone numbers.
